
BUSINESS TERMS AND CONDITIONS FOR THE PARTICIPATION OF EXHIBITORS

CONDITIONS OF PARTICIPATION

1. The delivery of the binding Registration Form to the address of Asociace zahradnického výstavnictví (Association of Horticultural Exhibition Management, hereinafter referred to as AZV) and the payment of the pro forma invoice for the registration fee and for the lease of the ordered area. The maturity date shall be specified on the invoice. As soon as AZV's account is credited with payment, the exhibitor becomes duly registered. As of that moment, a contractual relationship is established between the exhibitor and AZV.
2. In special cases and after the prior negotiation with the exhibitor, the organizer is entitled to adjust the area size and shape.
3. The condition for initiating the mounting of an exposition shall be the payment of the invoice by 10th August 2007.

TERMS OF PAYMENT

1. The price of the registration fee and area lease includes:
 - rent for the area in the period from 6th September from 8 a.m., to 9th September 2007 until 6.00 p.m.;
 - exhibitors' identification cards (for every 10m² one piece free)
 - mounting and dismounting card;
 - white back wall for model exhibitory areas;
2. Other individually ordered services must be paid by 10th August 2007.
3. Conditions of cancelling the participation:
 - in case of cancelling the binding Registration Form by 3rd August 2007, 30 % of the advance payment shall not be returned;
 - in case of cancelling it between 24th August 2007 and the opening of the fair, 100 % of the advance payment for area lease shall not be returned, including the registration fee.
4. All the prices provided in the price list are final. The Association is not a VAT payer. The organizer shall send his/her final invoice, with the deduction of advance payments, within 14 days after the closing of the fair.

TECHNICAL TERMS AND CONDITIONS

1. The fair will be opened on 7th September 2007 at 10.00 a.m., and closed on 8th September 2007 at 5.00 p.m.;
2. The mounting of expositions will be carried out on 6th September between 8.00 a.m. and 10.00 p.m.;
3. The dismounting of expositions will be carried out on 8th September between 5.00 p.m. and 9.00 p.m. or on 9th September between 8.00 a.m. and 6.00 p.m.;
4. The exhibition area shall be open for exhibitors daily, between 8.00 a.m. and 8.00 p.m.;
5. On the basis of an order, and after the prior consultation, the organizer shall provide at Veletrhy Brno, a.s. for stands mounting, electricity supply, equipment lending and technical material – see **BINDING REGISTRATION FORM** ;
6. The lessor of the exhibition hall (Veletrhy Brno, a.s.) provides for free the natural disasters insurance and conveyance structure damage. The lessor is irresponsible for loss or damage exhibitor's equipment (wares, wrappings, discards etc.);
7. At request, the organizer shall arrange accommodation for exhibitors;
8. The exhibitor is obliged to return the exhibition area in the condition that he/she took it over from the organizer by the deadline.
9. In order to ensure cleanliness in the exhibition area, containers for litter will be provided free of charge.
